Built around 1970 by the local authority, of traditional cavity brick construction externally rendered under a pitched tiled roof.

Overhall Crescent is located on the edge of town with open countryside to the rear and the award winning Wilton Lodge part to the front.

The accommodation comprises; Entrance Hallway, living room, dining kitchen and utility room on the ground floor with three double bedrooms all with fitted wardrobes and a shower room. In total around 94 SQM of living space.

Benefitting from GCH with Vailant combi-boiler and UPC double glazing. The property has excellent insulation throughout.


